Care plans are detailed and 'live' documents which describe the overall aims and desired outcomes for the individual child, based on a thorough assessment of their needs. The core feature of the child care planning process is for it to be child centred in achieving long term permanence for the child.

3.1.5 Care Plans Guidance

In Wales, The Care Planning, Placement and Case Review (Wales) Regulations 2015 set out the responsibilities of local authorities to plan looked after children 's care. The Welsh government has issued a code of practice for looked after and accommodated children (PDF) , which provides guidance on supporting looked after children, including:

The Children Act 1989 guidance and regulations

On the individual planning sheet include some information about the child, e.g., name, date of birth, name of key person, sessions attending. Other boxes that should be included with each week should be a box containing child 's interests and a next step box. It is also recommended to include an adult initiated activity section.

The care plan is a written document (either electronic or paper-based) that is used and altered constantly throughout the day. It 's based on a ' template ' which defines the areas the care plan covers.

Section 2 gives the procedure for commencing the care proceedings under the Public Law Outline. Section 3 is the care planning phase which commences when the care proceedings have been issued or when a child is accommodated under Section 20 of the Children Act 1989.

Good care planning supports the quality of the relationship between the child or young person and carer by minimising disruption, increasing attachment and providing greater placement stability, which also helps promote a stable education. Recommendation 5 Implement care planning, placement and case review regulations and guidance

SCIE/NICE recommendations on looked after children: Care ...

The Care Plan must be prepared prior to a child's first placement, or, if it not practicable to do so, within 10 working days of the first placement. The overall purpose of the Care Plan is to safeguard and promote the interests of the child, prevent drift and provide focus for work with the child and their family.

Permanency planning is the process of assessing and preparing a child for long term care when in out-of-home placements such as kinship, foster care or institutions. A care plan must centre on what is in the child 's best interests, and therefore requires an ongoing assessment of the child and her needs.
