### Ohio Consumer Laws - FindLaw

In Ohio Revised Code Section 3704.162 (C) (1), the law allows reasonable reimbursement of attorney's fees if the court finds the complainant has brought or maintained a groundless action. Reimbursement of attorney fees also may be awarded if the action was filed in bad faith or if the complainant has tampered with the vehicle after the sale.
