Respiratory Therapy Policy / Procedure Lung Volume Recruitment For Paralytic/Restrictive Disorders. Lung volume recruitment is a high-risk procedure that may generate droplets, exposing staff to respiratory pathogens. Appropriate Personal Protective Equipment (PPE) must be applied to reduce exposure to respiratory secretions.
